**LI BENNICH-BJÖRKMAN**, PhD, is the Johan Skytte Professor in Political Science at Uppsala University, Sweden. She has worked and published for many years, focusing on Eastern Europe and the Baltic States. She is interested in historical legacies and how they influence political developments and party formation in the new democracies. Political culture and exile communities often provide the material for her studies.

**STEPAN IVANYK** is the president of the Kazimierz Twardowski Philosophical Society of Lviv. He holds an MA from the Ivan Franko National University of Lviv (2004), an MA from the Center for East European Studies at the University of Warsaw (2010), and a PhD in philosophy from the Graduate School for Social Research at the Polish Academy of Sciences (2012). In 2012-18 he was an assistant professor at the Institute of Philosophy at the University of Warsaw. His research fields include the history of philosophy in Lviv, the history of Ukrainian philosophy, interrelations between Ukrainian and Polish philosophies, logical semiotics, and the theory of judgments. Ivanyk is the author of *Stepan Oleksiuk—Disciple of Kazimierz Twardowski* (Aral, 2012, in Ukrainian), *Ukrainian Philosophers in the Lviv-Warsaw School* (Semper, 2014, in Polish), co-author of *Stefan Baley in the Light of the Leading Philosophical Trends of the 20th Century* (Liga-Pres, 2014, in Ukrainian), co-editor of *Stefan Baley: Selected Psychological Works. Volumes 1-2* (Warsaw UP, 2016, in Polish) and *Theory of Judgments in the Lviv School of Philosophy. Anthology* (Kazimierz Twardowski Philosophical Society of Lviv Press, 2018, in Polish), and co-translator of *Kazimierz Twardowski. Selected Works* (Folio, 2019, in Ukrainian).

**ANDRIY KASHYN** is an independent social researcher and consultant in Kyiv, Ukraine. Since mid-2000, he has led numerous research projects and assessments focusing on the labour market and on tertiary education in Ukraine (for example, A National Study on Corruption in the Higher Education Sector in Ukraine; Compass: Ranking of Ukrainian Universities). His research interests include the humanitarian situation in Eastern Ukraine and the electoral preferences of Ukrainians.

**VOLODYMYR V. KRAVCHENKO** is a professor in the Department of History and Classics, and the director of Contemporary Ukraine Studies Programs at the Canadian Institute of Ukrainian Studies (University of Alberta). He is the author of about 170 articles, book chapters, and monographs concerning Ukrainian historiography (since the end of the 18th to the 21st centuries), historical legacy, and Kharkiv (city and region). His fields of interest include the history of East European, Soviet, and Russian studies.

**SERGIY KURBATOV**, PhD, is a senior researcher at the Institute of Higher Education, National Academy of Educational Sciences of Ukraine, and an affiliated researcher at the Institute for Russian and Eurasian Studies, University of Uppsala, Sweden. His interests include quality assurance in higher education and university rankings, political transformation in post-Soviet countries, and the philosophy of time.

**OLGA OLENIKOVA** holds a PhD in Sociology and Social Policy from the University of Sydney and is a director of the [Ukraine Democracy Initiative](#), based at the University of Technology Sydney and the University of Sydney, Australia. Established in April 2016, the Ukraine Democracy Initiative (UDI) is the first of its kind research platform at university level in Australia. It conducts research into Ukrainian political and social situations and the turbulent democratic transition of Ukraine. Oleinikova is also a lecturer at the School of Communication, University of Technology Sydney, and was awarded an Honorary Research title with the School of Social and Political Sciences, University of Sydney. In 2018, Oleinikova was named on the Forbes 30 Under 30 list of outstanding young leaders in Asia.

**JAROSLAV SKIRA** has been teaching at Regis College, University of Toronto, since 2001. Prior to joining Regis College, he held teaching positions at St. Michael's College, the Sheptytsky Institute of Eastern Christian Studies (Saint Paul University, Ottawa), and the Lviv Theological Academy (Ukrainian Catholic University, Ukraine). Since 2011, he has served as the founding director of the Graduate Centre for Theological Studies (Toronto School of Theology). He has published in the areas of Orthodox-Catholic ecumenical relations, modern Eastern Orthodox theology, and the Ukrainian Greco-Catholic Church. In addition to co-editing *In God's Hands: Essays on the Church and Ecumenism* (Peeters, 2006) and *Windows to the East: Eastern Christians in a Dialogue of Charity* (Novalis, 2001), he translated *The Second Vatican Council Diaries (1960-1965) of Metropolitan Maxim Hermaniuk* (Peeters, 2012).

**MYROSLAW TATARYN** is a professor of Religious Studies at St. Jerome's University (University of Waterloo). He previously served as vice-president and academic dean at St. Jerome's. His most recent work, *Discovering Trinity in Disability: A Theology for Embracing Difference* (Novalis, 2013), was co-authored with his wife Maria Truchan-Tataryn. He has authored papers concerning the history of the Ukrainian Greco-Catholic Church in Canada and on topics in Eastern Christian theology. Currently he is researching the impact of the Revolution of Dignity on religiosity in Ukraine.
